Please read and initial the following general conditions:

- I understand that this General Variance is for replacing or constructing a new Privacy Screen, <u>as described herein</u>, which has been pre-approved by the board. Any changes to the general design or details provided herein or other exterior work must be submitted to the board for approval.
- I understand that the length of the privacy screen cannot exceed 12 feet from the original back building wall (excluding storage room, see drawing) or from the original back wall to the setback line, whichever is shorter.
- _____ I understand that the privacy screen cannot exceed 5 feet in height.
- I understand that I cannot imped my neighbor's property or view and that I have discussed the proposed privacy screen with the neighbor and have attached documentation that they do not oppose construction of the wall.
- I understand that the Privacy Screen must comply with all city, county, and state building codes and regulations, it is the responsibility of the owner/contractor to obtain all necessary permits/approval prior to work beginning.

- I understand that only the specific work approved by the board may be done. Any job changes/modifications to the original approval must also be submitted to the board for additional approval.
- All work must be completed within 6 months of general variance submittal. The GHBR office must be notified before the work begins and also when the work is completed.
- Construction which results in movement of sprinkler lines, electrical lines or drainage lines, are subject to changes by the association. All necessary lines must be moved prior to implementation of variance and all fees paid in advance.
- _____ I will call 811 to have all utilities marked before any digging.
- _____ The privacy screen color shall be white for non-Grand Island homes and shall be Gulf Highlands Brown for Grand Island homes.
- I am the owner of the unit submitting the proposed general variance. Deviations from this general variance may result in disciplinary action in accordance with Gulf Highlands governing documents and rules, including failure to obtain a clear estoppel upon sale.


